1. Executive Summary

Armed Forces Day is a celebration event that attracts on average between 4 and 5 thousand people a year, most of which will be drawn from the Humber area. It is a family celebration with an opportunity to engage with attendees and inform them of how to engage with the work of the OPCC.

2. Recommendation(s)

That funding of £3,000 is provided to North Lincolnshire Council in exchange for sponsorship opportunities at the Armed Forces Day and in all promotional marketing for the event.

3. Background

North Lincolnshire Armed Forces Day is set for 2022 and will return to a physical event in June 2002 the event will take place on Saturday June 18th at Brumby Hall Sports Ground in Scunthorpe.

The event organised by North Lincolnshire Council is a family focused outdoor event with a combination of static displays, musical entertainment and arena displays.

The event recognises the unique sacrifice of our Armed Forces and give the local community with an opportunity to celebrate the work and contribution of the Armed Forces Community in North Lincolnshire

The event is organised by a local Events Committee and is attended by between 4 and 5 thousand people on an average year. This will be the first physical event for 2 years and there will be a real focus on making it a very special event and maximising attendance through a large amount of pre communications.

The event will include:

- A military parade
- Cadet Village and cadet games
- Static displays and living history exhibitions related to Armed Forces.
- Military organisations and charities
- Climbing wall

- Live music
- Birds of Prey display
- Children's entertainment

Local public sector organisations are represented and have an opportunity to engage with both the local community and the Armed Forces Community on a wide range of support and service provision.

The event is free to enter is a lively family focused event, with a concerted effort to ensure all displays and entertainment are in keeping with the purpose of the day.

4. Options

There are three options.

Option 1 - Do nothing - don't fund

This option is not recommended as it would be a lost opportunity for the Commissioner to engage with local people and raise awareness of the work of the office.

Option 2 – Fund partial contribution

Similar to option 1 the PCC could make a partial contribution but this would then require further sponsors to be identified.

Option 3 – Fund full amount

This option is recommended because it allows the PCC to capitalise on the sponsorship opportunity and secure the opportunity to capitalise on the pre – event communications.

5. Risks

The risks are minimal to the investment. There is money available due to underspend in core budget in 2021 due to impact of COVID, less travel etc and therefore this can be used to support the event as one off funding.

6. Contribution to Delivery of the Police and Crime Plan

This investment will contribute directly to aims one and two of the Police and Crime Plan through Engaged, Resilient and Inclusive Communities and Safer Communities.

7. Financial Implications

The budget requirement is £3,000 which will secure the event for 2022.
