Title: Police Treatment Centre donation

1. Executive Summary

The Police Treatment Centre is a charity supporting recovery of police officers and some police staff following injury both physically and psychologically. They have two facilities, one of which is located in Yorkshire and they treat in excess of 4000 people per year. They rely on donations to continue their work which often sees officers be able to return to service faster as a result of accessing care and recovery services.

2. Recommendation(s)

That funding of £15,000 is provided to the Police Treatment Centre to cover the term of the PCC to May 2024.

3. Background

The Police Treatment Centres is a registered Charity supported by voluntary donations from the Police Family primarily in the Northern forces of England and Wales, Scotland and Northern Ireland, but also from British Transport Police, the Civil Nuclear Constabulary and the Ministry of Defence Police. Officers currently make a donation from their pay of £1.80 per week (1 January 2016).

The Charity provides two Treatment Centres where Serving and Retired Police Officers can receive treatment following an illness or injury, with the aim of assisting their return to better health. The Centres are St Andrews, in Harrogate, North Yorkshire, and Castlebrae in Auchterarder, Perthshire. The Charity also offers a remote Physiotherapy service.

Almost 4000 Serving and Retired Officers attend the Treatment Centres each year and most receive intensive physiotherapy. Others seek support with stress-related conditions or anxiety and depression as part of our Psychological Wellbeing Programme.

The service has been recognised as beneficial for officers that have accessed the service from Humberside often seeing officers return to work and active duty quicker than would be possible if utilising the services of the NHS. Wellbeing of staff is important to securing an effective and efficient police service.

The Chief Executive of the Police Treatment Centre reached out to all PCCs in Autumn 2021. This resulted in the PCCs from the North East Region coming together to agree a regional donation that would cover the term of this election. The totality of the donation amounts to £120k over the three years, Humberside contribution to that is £15,000.

4. Options

There are three options.

Option 1 - Do nothing - don't fund

This option is not recommended as it would mean the Police Treatment Centre may continue to operate with funding gaps diminishing service available to police officers and staff.

Option 2 – Fund partial contribution

Similar to option 1 the PCC could make a partial contribution but this would then require further funding to be identified and risk diminished service.

Option 3 – Fund full amount

This option is recommended because it provides a meaningful contribution to a charity known to make an impact locally and is in line with donations being made across the North East Region.

5. Risks

The risks are minimal to the investment. There is money available due to underspend in core budget in 2021 due to impact of COVID, less travel etc and therefore this can be used to support.

This investment will contribute directly to aims three of the plan around effective organisations.
