**Title: Stephen Lawrence Foundation workshop**

**1. Executive Summary**

Beats Bus Records will deliver a local workshop with young people on the theme of 'What does kindness mean to you?' utilising the resources from the Stephen Lawrence Foundation to produce a 5 minute video for the memorial event on 22 April 2022.

**2. Recommendation(s)**

That funding of £760 is provided to Beats Bus Records for delivery of the workshop and production of the video by INIT Creative.

**3. Background**

Beats Bus Records are a not-for-profit social enterprise in Hull, they are unique in practice by combining a mobile professional recording studio with youth engagement and mentoring ability. Comprised of three tutors with Teaching qualifications, safeguarding and DBS clearance, they work with children and young people on issues of social justice, addressing racism, anti-poverty and inclusion among other key themes.

They wish to deliver a workshop with young people in the Peel street area of Hull, known recently for gang related and anti-social activity, to share with them the lessons learned from the Stephen Lawrence Foundation: <https://stephenlawrenceday.org> using a local community-led theme of 'What does kindness mean to you?'

The workshop and any learning will be captured by INIT Creative to produce a five minute video to then be streamed for an online event on 22 April 2022 to commemorate the life of Stephen Lawrence.

The funding will provide:

- 1 day workshop preparation and delivery – including equipment hire
- 1 day music production
- 1 day filming and editing

**4. Options**

There are three options.

Option 1 - Do nothing - don't fund

This option is not recommended as it would be a lost opportunity for the Commissioner to engage with young people and the wider community on issues of youth violence, anti-racism and community cohesion.

#### Option 2 – Fund partial contribution

Similar to option 1 the PCC could make a partial contribution but this would then require further grants to be identified.

#### Option 3 – Fund full amount

This option is recommended because it allows the PCC to help support young people's access to positive activities.

### **5. Risks**

The risks are minimal to the investment. There is money available in the budget.

### **6. Contribution to Delivery of the Police and Crime Plan**

This investment will contribute toward the aim of 'engaged, resilient and inclusive communities' in addition to the aim of 'safer communities'.

### **7. Financial Implications**

The budget requirement is a one-off payment of £760.

Costs as follows:

- £360 for the workshop
- £400 for the production
- Total £760
