1. Executive Summary

The PCC to sponsor a young people's volunteer celebration event for £100 in North East Lincolnshire in November 2022.

2. Recommendation(s)

To provide £100 to St Andrews Hospice who are facilitating the administration of the event to sponsor the Vigorous Volunteer award.

3. Background

A youth volunteer event is being organised in North East Lincolnshire to recognise young people volunteering. A clear part of the Police and Crime Plan is to encourage more people to volunteer and help keep their communities safe.

Sponsorship for the Vigorous Volunteer award is being sought for £100. The PCC will attend and present the award.

4. Options

There are three options.* More can be included and please include narrative for each option

Option 1 - Do nothing - don't fund

No recognition of the importance of volunteering and the priority in the Police and Crime Plan.

Option 2 – Fund partial contribution

Donation is minimal and provides good coverage with a target audience i.e. young people of the work of the PCC.

Option 3 – Fund full amount

The recommendation is the full £100 donation is made and that the opportunity is used to raise the profile of the work of the PCC with this cohort as well as ensure the priority in the Police and Crime Plan is advocated.
