**1. Executive Summary**

The PCC to sponsor the High Sheriff of East Riding to support an events programme engaging the business community in awareness raising of Violence Against Women and Girls (VWAG).

**2. Recommendation(s)**

To provide £1000 to Two Ridings Community Foundation who will keep the funds for the High Sheriff to access for her VWAG programme.

**3. Background**

The East Riding High Sheriff for East Riding, Jacky Bowes has chosen to focus her year in office on tackling violence against women and girls. This includes raising awareness of the scale of the issue and how people can help tackle.

A donation of £1000 is being sought to enable the High Sheriff to engage with the business community and run events to awareness raise and encourage action to tackle misogyny and violence against women within their workforces and wider communities.

**4. Options**

There are three options.\* More can be included and please include narrative for each option

Option 1 - Do nothing - don't fund

High Sheriff has no budget to engage with the community and this may scale the ability to reach those that would benefit from the intervention.

Option 2 – Fund partial contribution

Donation is minimal and will provide useful reach into priority community.

Option 3 – Fund full amount

The recommendation is the full £1000 donation is made and that the opportunity is used to raise the profile of the work of the PCC with this cohort. The OPCC has aspirations to create a business forum which may be a useful link from any engagement events held.
