# 1. Executive Summary

- 1.1 Support of the Humberside Police and Crime Commissioner (PCC) is sought to enable the development and delivery of a Humber wide campaign relating to Modern Day Slavery.
- 1.2 This Decision Record approves a project to develop and deliver a comprehensive Modern Day Slavery campaign programme aimed at reducing the number of people who have become modern day slaves
- 1.3 The campaign will raise awareness of Modern Day Slavery and how to report concerns and ensure that there is a victim focused approach that sees improved identification and support for victims as well as improved knowledge among the public and professionals.
- 1.4 The campaign will include other key themes linked to Modern Day Slavery including:
  - i) Labour abuse
  - ii) Domestic servitude
  - iii) Juvenile Labour
  - iv) Sexual exploitation

#### 2. Recommendation(s)

2.1 It is recommended that the OPCC provides £20,000 in this financial year to fund the development and delivery of a comprehensive Modern Day Slavery Campaign across the Humber region.

#### 3. Background

3.1 We know from academic work that has taken place locally and national reports on the theme of Modern Day Slavery that exploitation through business activities and supply chains remains an ongoing problem that can often be hidden in plain sight.

3.2 Whilst a partnership approach work has been undertaken previously to combat Modern Day Slavery it is important that members of the public know how to report concerns, how professionals can identify victims and how victims can report directly and confidentially.

## 4. Options

- 1) Do nothing the decision not to fund this campaign would result in the continuation of the current offer which is fragmented and does not appear to be joined up.
- 2) Partially fund the decision to partially fund would result in only some of the elements being delivered for example social media only, therefore not reaching the intended audience.
- 3) Fully fund (preferred option) This option would allow the campaign to reach all areas of the Humber region and increase the number of people being made aware of / or victims of Modern-Day Slavery.

#### 5. Financial Implications

5.1 The preferred option requires a commitment of £20,000 in this financial year. Consultation with finance has confirmed that there is the budget available to fund this campaign.

#### 6. Legal Implications

6.1 No legal implications identified for this campaign.

## 7. Driver for Change/Contribution to Delivery of the Police and Crime Plan

- 7.1 The Police and Crime Plan has 'Safer Communities' as one of the three aims. The objective within states that the PCC will raise awareness of and tackle hidden harms with partners e.g., child exploitation and modern slavery.
- 7.2 In addition, there is a commitment from the Police and Crime Commissioner to raise awareness of child exploitation and modern slavery.

8.1 No equality implications have been identified for the OPCC. We will work with the CSP leads and other statutory partners who are subject to the Public Sector Equality Duty.

9.1 Consultation has been carried out with the four Community Safety Partnership (CSP) leads, finance, comms, and the Chief Executive.
