

Dear , thank you for your requests for information dated 4 and 6 February 2017.

1. How many times in 2016 your respective police forces attended "illegal hunts using dogs"?
2. How many arrests, charges, cautions and prosecutions were made by your respective police forces? Could this information be sorted into pro hunt and anti hunt cases please?
3. How many complaints were made to your respective police forces alleging assault and intimidation and by whom (pro hunt/anti hunt)?
4. How many of the complaints from 3. above resulted in your police officers "refusing" to take the correct and appropriate action?

None of the information requested in the 4 questions above is held by the Office of the Police and Crime Commissioner for Humberside. It may be held by Humberside Police and I would be happy to transfer your request to them if you advise that you would wish me to do so. 5. What is your official policy on policing "illegal hunts using dogs"?

I note in your second email that you are requesting this information specifically in relation to the Police and Crime Commissioner and can advise that the Police and Crime Commissioner for Humberside does not have an official policy on "illegal hunts using dogs". There is therefore no information held in relation to this part of your request.

1. What is the official policy of the PCC on their individual police forces FAILING to police illegal hunts properly and take appropriate action when informed of and presented with evidence of assault and intimidation?

The Police and Crime Commissioner for Humberside does not have any such official policy. In line with legislation complaints regarding police "failings" would, in the first instance, be referred to the Professional Standards Branch of Humberside Police. There is therefore no information held in relation to this part of your request.

2. If the PCC does not hold the information requested in my original email, does it hold ANY information on ANY subject relating to the performance of their individual police forces? If so, could I please have details of the type of information held.
