Prior to 2013/14 the PCC did not receive money from the MoJ to support Victim Services. A grant was received in 2013/14 to prepare for the transfer of responsibilities for victims to PCCs with effect from 01.10.14. The funding in 2013/14 was spent on preparation costs and restorative justice with no contributions direct to support organisations.

2. Has the PCC/Mayor/Authority given any consideration to any waiting lists for rape and sexual violence support, and how such waiting lists can be mitigated against. If so, please provide details.

The PCC is aware of waiting lists, particularly with respect to therapeutic support services for victims of rape and serious sexual abuse as well as domestic abuse. Survivors of violence and abuse are often very distressed and they need to know what health services/therapies are available to promote their long term recovery. To mitigate this the PCC, in conjunction with the City Healthcare Partnership submitted a bid to the Home Office Violence Against Women and Girls (VAWG) Fund but unfortunately this bid was unsuccessful. As a result of this the PCC is currently engaging with the Clinical Commissioning Groups to try and ascertain what statutory services are available across the Humberside area and are the care pathways known and understood so that the SARC or ISVA services are confident that they can refer victims to these services.
